

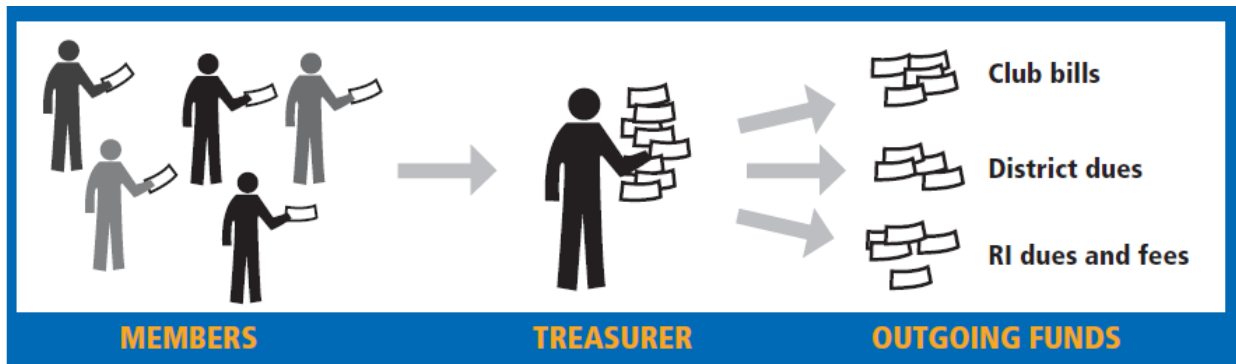


ROTARY CLUB OF PICKERING MEMBERSHIP GUIDE

WHAT IS THE FEE STRUCTURE?

Becoming a Rotary member connects you with a diverse group of professionals who share your drive to give back. Through regular meetings and events, you will:

- Discuss your community's needs and develop creative ways to meet them
- Connect with other leaders who are changing the world
- Expand your leadership and professional skills
- Catch up with good friends and meet new ones



Membership fees are split between Rotary International, Rotary District 7070 and the Rotary Club of Pickering. Money collected is dedicated to enhancing your experience by providing the tools and resources needed to connect with others and make a difference in the world. Other benefits of membership include:

Rotary Global Rewards, our member benefits program, which offers discounts on products and services. It's Rotary's way of helping our members spend less so they can do more.

The Rotary International Convention is our biggest event of the year. Rotary members from more than 130 countries meet at the convention each year to celebrate our successes and make plans for the future.

Rotary Fellowships give members the chance to join a group of people who share similar interests, hobbies, or vocations. Some groups use their fellowship to make a positive difference.

Rotarian Action Groups unite Rotary members, family members, program participants and alumni who share their expertise in particular fields by collaborating with clubs and districts on projects.

FEE SCHEDULE

(JULY 1, 2020 - JUNE 30, 2021)

Individual Member

Annual membership fees are payable by Members in the amount of \$300 per annum. This includes Rotary International dues (\$126), District 7070 dues (\$55.00), and Rotary Club of Pickering dues (\$119).

Corporate Member

Corporate membership is open to any business, nonprofit, or government entity. Annual membership dues are payable by Corporate Members which will entitle the corporation to designate two members to participate in Rotary activities as corporate designee members.

WHAT'S THE ADVANTAGE OF A CORPORATION MEMBERSHIP?
Reduces the time commitment of any one member by allowing employees to attend meetings or events on each other's behalf
Elevates the corporation's image in the community as a partner in service and business committed to corporate social responsibilities.
Offers worker the chance to develop and apply leadership and professional skills such as project management, training and public speaking
Gives corporate members access to Rotary's global network of 1.2 million volunteers and the opportunity to network while traveling.
Emphasizes a commitment to serving others as part of the corporate culture, something workers will appreciate.

The Rotary Club of Pickering charges an organization a flat rate fee of \$700 for two corporate members per organization and both may regularly attend the club's meetings. RI dues for all corporate members are included in the flat rate. All corporate members are full, active members of the club and are listed on the club's membership roster in Rotary's database.

For the period of July 1, 2020 to June 30, 2021 Club membership includes Rotary International dues x 2 (\$252), District 7070 dues x 2 (\$110.00) and Corporate Membership fee (\$338) for a total \$700.00. Add \$250 for each additional employee. Add \$300 to add company logo to Rotary Club of Pickering's website

Dues for Dual Rotaract and Rotary Members

Annual membership fee for dual Rotaract and Rotary members are designed to make the introduction into Rotary more affordable. Until age 30, dual members would pay their Rotaract dues plus the Rotary International and District 7070 base dues. After age 30 and until the age of 40, for the first three years of Rotary membership, the dues would be equivalent to the Rotary International and District 7070 base dues only. For the period of July 1, 2020 to June 30, 2021 the Rotary International dues (\$126) and District 7070 dues (\$55.00) total \$181.00.

Dues for “Under 40” Individuals

Annual membership fee for young professionals under the age of 40 years are discounted to make the introduction into Rotary more affordable. For the first three years of membership, the dues would be equivalent to the Rotary International and District 7070 base dues only. For the period of July 1, 2020 to June 30, 2021 the Rotary International dues (\$126) and District 7070 dues (\$55.00) total \$181.00.

Dues for Family Members

Annual membership fee for family members are discounted to make Rotary membership more affordable. The Spouse/Partner Family Member pays 50 percent of an Individual Member’s club fees and 100 percent of the Rotary International and District fees. For the period of July 1, 2020 to June 30, 2021, Rotary International dues are \$126.00, District 7070 dues are \$55.00, and fifty percent of the Rotary Club of Pickering dues would be \$60.00 for a total of \$241.00.

Proration of Annual Fees

The Rotary year is from July 1 to June 30. When a Member joins Rotary mid-year, the annual fee for that year would be prorated based on months.

For example, if an Individual Member joined in January, the fee would be calculated as follows: \$25.00 multiplied by 6 months (January – June) for a total of \$150.00 for the remainder of the Rotary year.

For example, if a Corporate Member joined in January, the due would be calculated as follows: \$58.33 multiplied by 6 months (January – June) for a total of \$350.00 + \$125 per additional employee + \$150 to add logo to website for the remainder of the Rotary year.

For example, if an individual under 40 years of age joins Rotary mid-year, the Year 1 fee would be calculated as follows: \$15.08 multiplied by 6 months (January – June) for a total of \$90.48 for the remainder of the Rotary year.

For example, if a dual Rotaract-Rotary member joins in January, the fee would be calculated as follows: \$15.08 multiplied by 6 months (January – June) for a total of \$90.48 for the remainder of the Rotary year.

For example, if a Family member joins in January, the fee would be calculated as follows: \$20.04 multiplied by 6 months (January-June) for a total of \$120.24 for the remainder of the Rotary year.

CLUB MEAL FEES

Members are responsible for paying for their own meals at Club meetings and events.

Payable at the Door.

Community speakers and first-time visitors to the Rotary Club of Pickering are not charged a meeting or meal fee. Visiting Rotarians are charged.
